## Now the Sol witnesseth and the Parties hereby confirm and acknowledge that:

#### **Binding Effect:**

This SoI is only intended to set out the broad terms of understanding on a preliminary basis between the Parties. This SoI does not create binding obligations between the Parties. However, for the purpose of effectuating this SoI and to give legal and binding effect the Parties may enter into and execute the detailed contracts detailing the responsibilities, rights, obligations, representations, warranties, undertakings consideration/fees/compensation, etc.

The EDII and IIEC may, at their sole discretion, and further subject to internal approvals, make reasonable efforts to execute the following.

- IIEC agrees to work with EDII for creation of joint courses and programs in entrepreneurship development and execute them jointly through a joint certification
- IIEC and EDII will jointly conduct Entrepreneurship Development programs for Ecommerce professionals for the promotion of Entrepreneurship.
- IIEC shall support access to students from IIEC to EDII for awareness of entrepreneurship

#### **Execution of Detailed Contracts**

In order to effectuate the broad terms stipulated in this SoI, the Parties agree to negotiate in good faith and execute such legally binding detailed contracts as may be necessary.

## **Third Party Rights**

This Sol does not confer any rights or benefits on any third party.

### Effective Date

The effective date of this SoI is the date it has been signed by all the Parties to the SoI.

## **Validity and Extension**

This SOI shall be effective from the Effective Date and shall expire after a period of eighteen months unless extended in writing with mutual consent of the Parties. Either Party may terminate this SOI without cause upon thirty (30) days prior written notice to the other Party.

## Amendment of Sol

This SoI may be amended provided that any such amendments are agreed to in writing by the Parties.

## Representations, Warranties and Authority

The parties warrant that this SoI is validly formed according to the laws of India, and that they have full authority to enter into this SoI. They also warrant that all the required essential sanctions to enter into this SoI were obtained.
